We are proud of the strides we made in 2012, that brought us closer to achieving our mission of **empowering and giving hope to individuals and families affected by facial differences**. CCA focused on empowering families affected by facial differences by addressing issues such as education, family support and public awareness.

Overviews addressing tolerance, family dynamics and dealing with Rigid External Distraction were published which brought our library of educational materials to 14 syndrome booklets and 13 overviews. These publications arm families with knowledge and understanding of syndromes and associated medical and psychosocial issues. Three newsletters were published that not only educate families, donors and the public, but are a powerful support device that help families feel connected to others who have similar circumstances. The family retreat was held in Tempe, Arizona and our families have deemed the retreat CCA's most important program.

Public awareness is always high on our list of priorities and in 2012 a very important book was published that would drastically enhance our ability not only to spread awareness of craniofacial conditions, but to make "choosing to be kind" a cool thing to do. **Wonder** by R.J. Palacio is an award-winning best seller about Auggie, a 5th grader who has a craniofacial condition and is entering public school for the first time. It tells of Auggie's personal disappointments and triumphs. CCA is using this important teaching tool as the centerpiece of our awareness effort moving forward.

We are proud of the programs and services we offer families affected by facial differences. CCA is grateful for our donors and the families and friends who are out there working hard to ensure these programs and services continue. During these tenuous times, many nonprofits are cutting their services. Because of the hard work of our families and the steadfast support of our donors, CCA has been able to sustain our programs and services and continue to empower and give hope to thousands of families across the country and beyond, and move onward toward our vision of a world where all people are accepted for who they are, not how they look.

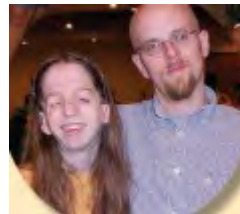

22nd Annual Cher's Family Retreat

The Annual Family Retreat is a weekend long empowerment exercise. CCA's 2012 Annual Family Retreat was a huge success, with 87 families attending from 25 states, Australia and Canada. In a survey, our families determined the retreat is CCA's most important program. The 22nd Annual Family Retreat was held in Tempe, Arizona. The Retreat has been referred to as "a booster shot that gets me through the year." It's hard to put into words the impact this weekend gathering has on families affected by facial differences. The three-day event, what many call "a life-changing experience," addresses the unique needs of each of these family members.

This year professionals from the craniofacial medical team in Phoenix presented at the 4th Annual Craniofacial symposium held on Thursday. These generous health-care providers donated their time and talent to provide this educational and esteem - building component of the Retreat. Sessions included topics such as dealing with bullying, getting prepared for college, parenting, and more. All were designed to educate and empower each member of the family.



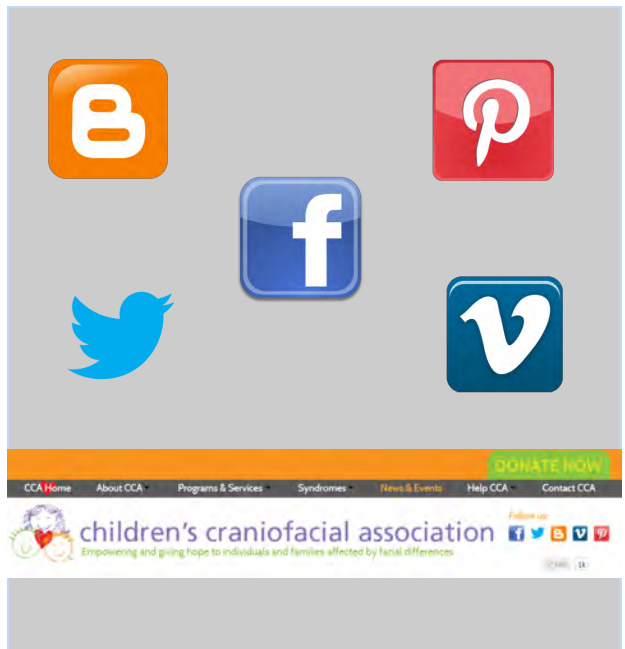
Education & Support



CCA is on a mission to **Empower** each member of the CCA family. We believe knowledge is power so we continue to build our arsenal of informative educational materials . In 2012 CCA published 3 newsletters and added 3 Overviews. We now have 14 syndrome booklets and 13 overviews available. CCA is the only organization with such a comprehensive offering of printed educational materials.

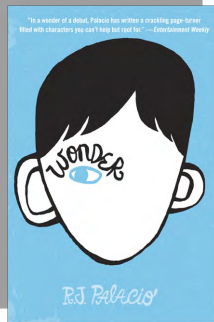


Public Awareness



Awareness Fosters Acceptance

In 2012 a once-in-a-lifetime public awareness opportunity revealed itself to CCA in the form of the book *Wonder* by R.J. Palacio. It is a book about a 5th grader starting public school for the first time. The book is a *New York Times* Best Seller and has received countless awards. Best of all, it promotes acceptance of kids with facial differences. The book promotes the message to “Choose Kind” and that’s the message CCA will take to schools across the country and around which we will build a national public awareness effort.

CCA continues to raise public awareness of individuals with facial differences and in 2012 we observed the 8th Annual Craniofacial Acceptance Month. And, thanks to Congressman Lou Barletta, it became part of the congressional record.

The “Beyond the Face is a Heart” campaign is designed to remind folks to look beyond facial differences to the real person within.

Resource Development



A phenomenon began a few years ago that has not only aided our ability to raise much needed funds to support CCA's programs and services, but also validated the organization's importance to the families we serve. That phenomenon is CCA's Family Fundraisers. In 2012 the families we serve raised funds in an amount over one half of our annual budget. It all began in 2003 when one family from Michigan called to tell us they were holding a charity golf tournament that would benefit CCA. From then on it's been a snowball effect and each year more families are holding events to raise funds. In 2012 CCA Board members, families, and friends held 15 major fundraising events that raised \$194,000. Another 20 smaller, but no less important fundraisers were held, totaling around \$23,000. Fundraisers included golf tournaments, 5K Runs, Motorcycle Rides, Sports Benefit Nights, Bowling Tournaments, Garage Sales, Blue Jean Days, First Giving Donation Pages and many more.

We cannot thank our families enough for rolling up their sleeves and pitching in during a time when many charities are finding funds difficult to procure, forcing them to cut programs or even dissolve. Because of these efforts, CCA has been able to maintain and enhance programs to serve more families affected by facial differences.

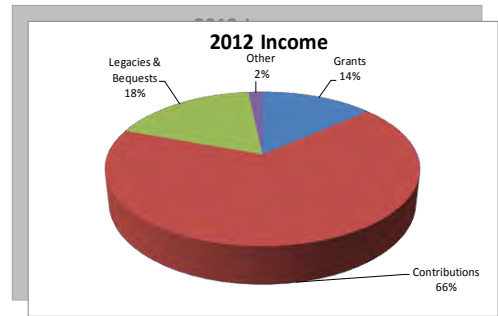
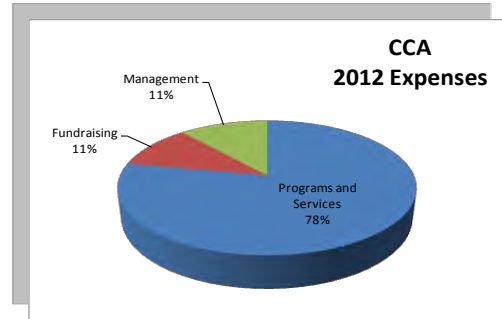
